What is the intended benefit of the rule?

This chapter describes the Department of Revenue's role in the Reinvestment Districts Program, including the calculation and remittance of the sales tax increment. The Department is required by Iowa Code section 15J.6 to have rules describing this information. The intent is to describe aspects of the calculation and remittance that may otherwise be confusing to the public.

Yes. The Department determined that the rules that are being re-promulgated would aid local jurisdictions and the public in understanding the calculation and remittance.
