## Iowa Fuel Tax Exemption Certificate Instructions

### Instructions

This exemption certificate is valid for Liquefied Petroleum Gas (LPG), Liquefied Natural Gas (LNG), Compressed Natural Gas (CNG), Electric Fuel, or Hydrogen only.

All portions of the exemption certificate must be completed. This form is only valid if signed by the purchaser. The seller must retain this certificate as proof that exemption has been properly claimed.

This certificate is required only when fuel is withdrawn from highway storage for exempt purposes.

Exemptions are limited to the following:

- a. Placed directly into the fuel supply tank or battery of a non-highway motor vehicle.
- b. Placed directly into a fuel supply tank or battery, which is connected to the heating or cooling unit installed on a highway "reefer" unit, provided the fuel supply tank or battery is not connected nor has provisions for connection directly or indirectly to the power source of the highway motor vehicle.
- c. Placed into carryout containers.
- d. Electric fuel used for a nontaxable purpose defined in Iowa Code 452A.17.

**Type of Certificate:** Check the box for a single purchase or blanket certificate. If for a single purchase, enter the related invoice number. If for a blanket certificate, enter the period this certificate is valid for. A blanket certificate may be valid for up to three years.
