



The Iowa Leading Indicators Index (ILII) fell to 107.1 (100=1999) in August 2015 from a 107.5 in July. The Iowa non-farm employment coincident index recorded a 0.12 percent rise in August, which extends the streak of employment gains to 59 consecutive months.

During the six-month span through August, the ILII decreased 2.3 percent (an annualized rate of -4.6 percent). The six-month diffusion index increased to 31.3 with five of the eight components (agricultural futures profits index, diesel fuel consumption, Iowa stock market index, new orders index, and residential building permits) experiencing a decrease of greater than 0.05 percent over the last half a year, with average manufacturing hours moving out of the list this month.

In August, only two of eight Iowa Leading Indicators Index components contributed positively. The positive contributors were average weekly manufacturing hours and average weekly unemployment claims (inverted). The agricultural futures profits index, the Iowa stock market index, the national yield spread, diesel fuel consumption, residential building permits, and the new orders index were the six components that contributed to the index negatively.

Figure 1. Iowa Leading Indicators Index and Iowa Non-Farm Employment Coincident Index: January 1999-August 2015



a. Percentage changes in the ILII do not always equal changes in the level of the ILII due to rounding.

b. A diffusion index measures the proportion of components that are rising based on the actual changes (not the standardized contributions to the ILII). Components experiencing increases greater than 0.05 percent are assigned a value of 1.0, components that experience changes less than an absolute value of 0.05 percent are assigned a value of 0.5, and components experiencing decreases greater than 0.05 percent are assigned a value of 0.0.

b. The agricultural futures profits index is computed as the sum of the standardized symmetric percent changes in the four series, each weighted by the commodity's annual share of Iowa cash farm income (updated August 25, 2015).

c. Arrows indicate the direction of the series' contribution to the ILII for the latest month.

d. Changes in average weekly initial unemployment insurance claims are inverted when added to the ILII, thus a negative change in the series contributes positively to the index.

ILII Components

- **Average weekly manufacturing hours:** Weekly average of hours worked in the manufacturing sector in Iowa. Changes are calculated based on a 12-month moving average. For August 2015, this component contributed 0.02 to the ILII value with its increase to 42.02 from 41.99. August 2015 hours were 42.4, above the 42.0 hours in August 2014, and 1.2 hours above the historical monthly average of 41.2 (1996-2014).
- **Average weekly unemployment claims:** Weekly average of initial claims for unemployment insurance in Iowa. Changes are calculated based on a 12-month moving average and are inverted when added to the ILII. This component contributed 0.00 to the ILII value. The 12-month moving average of claims decreased to 3,047 with unemployment claims for the month 0.8 percent below August 2014 claims, and 5.8 percent below average historical claims for August (1987-2014).
- **New orders index:** Diffusion index measuring the share of purchasing managers in Iowa reporting increases in orders received for manufacturing output. Changes are calculated based on a 12-month moving average. Although the monthly value of the index increased to 55.1 in August from 49.5 in July, it is down from 57.8 one year ago. The 12-month moving average of the new orders index dropped to 51.6, contributing -0.01 to the ILII.
- **Residential building permits:** Number of total permits issued in Iowa for the construction of residential housing units. Changes are calculated based on a 12-month moving average. For August, this component contributed -0.02 to the ILII with the 12-month moving average decreasing from 868 in July to 862. August 2015 permits were 7.0 percent below August 2014, and 16.4 percent below the historical average for August (1998-2014).
- **Diesel fuel consumption:** Number of taxable gallons of diesel fuel sold in Iowa. Changes are calculated based on a 12-month moving average. Diesel fuel consumption decreased 3.2 percent between August 2014 and 2015, causing the 12-month moving average to fall to 58.81 million gallons from 58.98 in July, and contributing -0.05 to the ILII value.
- **Yield spread:** Difference between the yield on 10-year Treasury bonds and 3-month Treasury bills. During August, the yield spread contracted to 2.10 percent as the long-term rate decreased fifteen basis points while the short-term rate increased four basis points. For the month, the yield spread contributed -0.06 to the ILII.
- **Iowa stock market index:** Capitalization-weighted index of 35 Iowa-based or Iowa-concentrated publicly-traded companies. During August 2015, only 7 of the 35 companies gained value, including 3 of the 12 financial-sector companies. With four-fifths of the stocks recording losses the index fell to 90.43 in August from 93.96 in July and contributed -0.07 to the ILII value.
- **Agricultural futures profits index:** Composite measure of corn, soybean, hog, and cattle expected profits, measured as the futures price less estimated breakeven costs, weighted by the respective share of Iowa annual cash receipts in the prior calendar year. Changes are calculated based on a 12-month moving average. During August this component contributed -0.17 to the index with expected profit decreases for three of the four commodities. Compared to last year, new crop corn prices are up 2.6 percent, while soybean prices are 12.9 percent lower. August prices for hogs are down 31.1 percent and cattle prices are 3.9 percent below August 2014.

The standardization factors are the inverse of the standard deviation of the month-to-month changes in each component over the January 1999 to June 2015 period. These factors equalize the volatility of the contribution from each component and are normalized to one. The month-to-month changes are based on 12-month backward moving averages for all components except the yield spread and the Iowa stock market index. The yield spread and new orders index changes are simple arithmetic changes; month-to-month changes for the rest of the components are computed as symmetric percentage changes. The factors are updated annually during August.

Comments

The Iowa Leading Indicators Index (ILII) is designed to forecast the future direction of economic activity in the state of Iowa. The techniques used to build the ILII follow those used by The Conference Board to construct the national Leading Economics Index (LEI) prior to the 2001 revisions. A one-month movement in such an index does not produce a clear signal, rather it is necessary to consider the direction of the index over several consecutive months. A contraction signal in the ILII is considered reliable when two conditions are met: 1. The index declines by at least two percent over a six month period (using an annualized rate); and, 2. A majority of the individual components decline over those six months (the six-month diffusion index less than 50.0).

The Iowa non-farm employment coincident index measures the change in non-seasonally adjusted, total non-farm employment in the state of Iowa. Changes are based on a 12-month moving average of employment and are computed as symmetric percentage changes. The index is a representation of overall economic activity in Iowa.

The employment index and the ILII are constructed to have a value of 100 in the year 1999.
