

The Iowa Leading Indicators Index (ILII) decreased to 105.5 (100=1999) in April from 105.6 in March. The monthly diffusion index decreased to 37.5 in April from a revised 43.8 in March. The Iowa nonfarm employment coincident index recorded a 0.12 percent increase in April. Long term trends in the ILII suggest that nonfarm employment will increase over the next three to six months with no contractionary signal.

During the six-month span through April, the ILII decreased 0.1 percent (an annualized rate of -0.1 percent). The six-month diffusion index increased to 37.5 in April from 25.0 in March. The ILII was constructed to signal economic turning points with two key metrics that when seen together are considered a signal of a coming contraction: a six-month annualized change in the index below -2.0 percent and a six-month diffusion index below 50.0. The six-month diffusion index remained in a contractionary signal for the sixteenth month in a row while the six-month annualized change was above a contractionary signal for the second month in a row. Five of the eight component indicators decreased more than 0.05 percent over the last half-year: the agricultural futures profits index (AFPI), diesel fuel consumption, the national yield spread, new orders index, residential building permits, and initial unemployment insurance claims. Average manufacturing hours, the Iowa Stock Market index, and the national yield spread were the only components to increase by more than 0.05 percent over the last six months.

Three of the eight components increased month over month in April: The national yield spread, the Iowa Stock Market Index, and average manufacturing hours. Diesel fuel consumption, the AFPI, average weekly unemployment claims (inverted), the new orders index, and residential building permits detracted from the Index.

Figure 1. Iowa Leading Indicators Index and Iowa Nonfarm Employment Coincident Index: January 1999 - April 2024

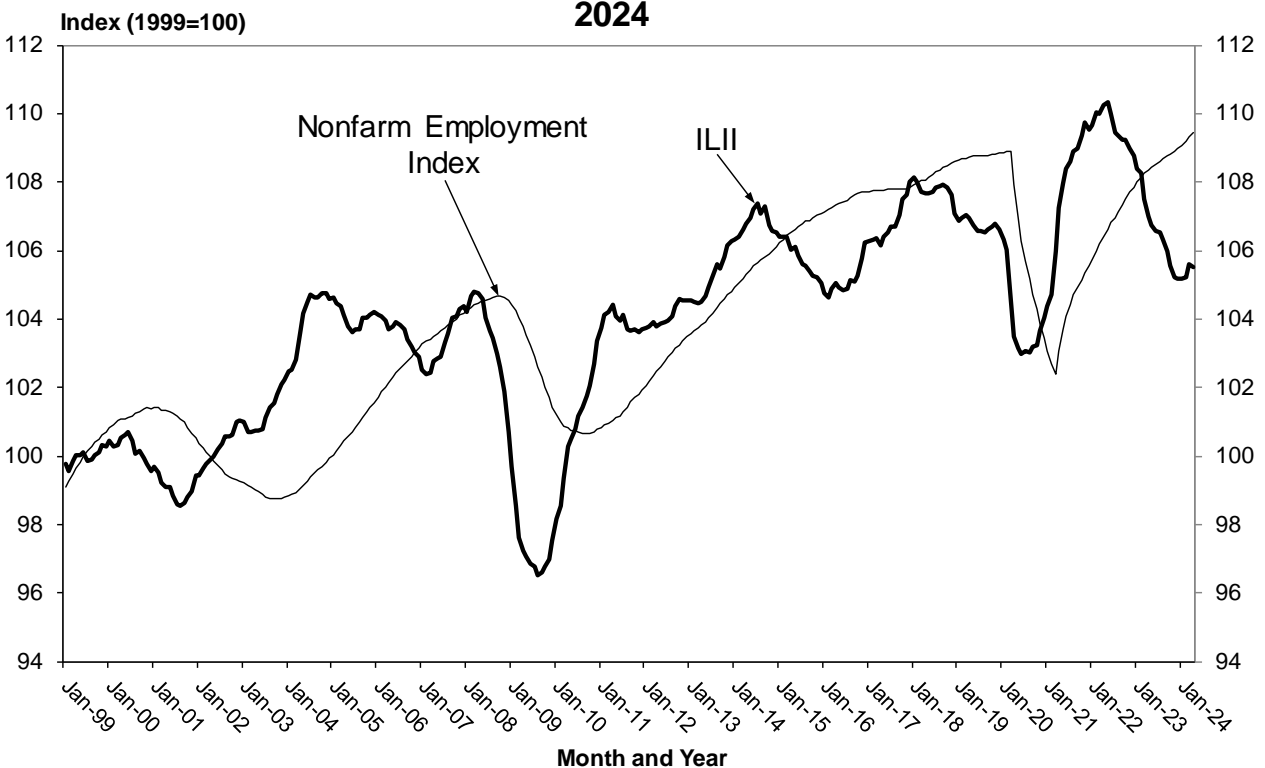

b. A diffusion index measures the proportion of components that are rising based on the actual changes (not the standardized contributions to the ILII). Components experiencing increases greater than 0.05 percent are assigned a value of 1.0, components that experience changes less than an absolute value of 0.05 percent are assigned a value of 0.5, and components experiencing decreases greater than 0.05 percent are assigned a value of 0.0.

ILII Components

- **Yield spread:** Difference between the yield on 10-year Treasury bonds and 3-month Treasury bills. During April, the yield spread remained in inversion territory (below 0) at -0.90 percent, up from -1.26 percent in March. April is the eighteenth month in a row that the yield spread has been in inversion. The long-term rate increased 33 basis points while the short-term rate decreased by 3 basis points. For the month, the yield spread contributed 0.12 to the ILII value.
- **Iowa stock market index:** Capitalization-weighted index of 28 Iowa-based or Iowa-concentrated publicly-traded companies. During April, 14 of the 28 companies gained value, and 3 of the 10 financial-sector companies increased. With nearly half of the stocks experiencing gains, the index increased to 139.2 in April from 131.6 in March, contributing 0.09 to the ILII value.
- **Average weekly manufacturing hours:** Weekly average of hours worked in the manufacturing sector in Iowa. Changes are calculated based on a 12-month moving average. For April, this component contributed 0.04 to the ILII with the 12-month moving average increasing to 39.81 in April from 39.76 in March. In April, average hours were 39.9, just under an hour below the historical monthly average (1996-2023).
- **Residential building permits:** Number of total permits issued in Iowa for the construction of residential housing units. Changes are calculated based on a 12-month moving average. In April, permits were 894, down from 924 last year. This component detracted 0.01 from the April ILII with the 12-month moving average decreasing to 908 in April from 911 in March. April 2024 permits were 3.3 percent below April 2023, and 27.0 percent below the monthly historical average (1998-2023).
- **New orders index:** Diffusion index measuring the share of purchasing managers in Iowa reporting increases in orders received for manufacturing output. Changes are calculated based on a 12-month moving average. The new orders index in April increased to 59.3 from 48.5 in March. However, the 12-month moving average of the new orders index has decreased to 48.9 from 49.1 in March, and detracted 0.01 from the ILII.
- **Average weekly unemployment claims:** Weekly average of initial claims for unemployment insurance in Iowa. Changes are calculated based on a 12-month moving average and are inverted when added to the ILII. This component detracted 0.02 from the ILII value, with the 12-month moving average of claims increasing from 2,377 to 2,416. Unemployment claims were 32.0 percent above April 2023 claims, yet 47.5 percent below average historical claims for April (1988-2023).
- **Agricultural futures profits index:** Composite measure of corn and soybean expected profits, measured as the 12-month moving average of the futures price less estimated breakeven costs, and cattle and hog expected profits, measured as the average of the crush margin for the next 12 months, weighted by the respective share of Iowa annual cash receipts averaged over the prior ten calendar years. During April, this component detracted 0.11 from the ILII with expected profits decreases in both crop commodities and expected profit decreases in both livestock commodities. Compared to last year, new crop corn prices were 15.4 percent lower while soybean prices were 9.7 percent lower. The April crush margin for cattle decreased 10.7 percent from March while the crush margin for hogs decreased 1.9 percent.
- **Diesel fuel consumption:** Number of taxable gallons of diesel fuel sold in Iowa. Changes are calculated based on a 12-month moving average. Diesel fuel consumption decreased 11.8 percent between April 2023 and April 2024. The 12-month moving average decreased to 64.84 million gallons in April from 65.57 million in March, detracting 0.20 from the ILII value.

The standardization factors are the inverse of the standard deviation of the month-to-month changes in each component over the January 1999 to June 2023 period. These factors equalize the volatility of the contribution from each component and are normalized to one. The month-to-month changes are based on 12-month backward moving averages for all components except the agricultural futures profits index, the Iowa stock market index, and yield spread. The yield spread and new orders index changes are simple arithmetic changes; month-to-month changes for the rest of the components are computed as symmetric percentage changes.

The factors are updated annually during August.

Comments

The Iowa Leading Indicators Index (ILII) is designed to forecast the future direction of economic activity in the state of Iowa. The techniques used to build the ILII follow those used by The Conference Board to construct the national Leading Economics Index (LEI) prior to the 2001 revisions. A one-month movement in such an index does not produce a clear signal, rather it is necessary to consider the direction of the index over several consecutive months. A contraction signal in the ILII is considered reliable when two conditions are met: 1. The index declines by at least two percent over a six-month period (using an annualized rate); and, 2. A majority of the individual components decline over those six months (the six-month diffusion index less than 50.0).

The Iowa nonfarm employment coincident index measures the change in non-seasonally adjusted, total nonfarm employment in the state of Iowa. Changes are based on a 12-month moving average of employment and are computed as symmetric percentage changes. The index is a representation of overall economic activity in Iowa.

The employment index and the ILII are constructed to have a value of 100 in the year 1999.
