#### What is the intended benefit of the rule?

Chapter 531—20 is intended to provide generally applicable rules that govern all of the Iowa Lottery's computerized games. The computerized games offered by the Iowa Lottery further the Lottery's goals of providing continued entertainment to the public while maximizing revenues. The rules are intended to ensure that computerized games are conducted fairly and with integrity.

#### Is the benefit being achieved? Please provide evidence.

Yes. In 2023, the lowa Lottery reported sales of tickets or entries in computerized games totaling \$143,123,790. Sales of tickets or entries in computerized games accounted for 29.7% of total lottery sales in 2023.

## What are the costs incurred by the public to comply with the rule?

Players who choose to purchase tickets or entries in the computerized games offered by the Iowa Lottery incur the cost of the ticket or entry as specified in the game specific rules governing the computerized game in which they enter.

## What are the costs to the agency or any other agency to implement/enforce the rule?

The agency incurs no costs to administer this rule chapter beyond those costs envisioned by chapter 99G of the Iowa Code. Under section 99G.38, the Iowa Lottery is self-funded.

#### Do the costs justify the benefits achieved? Please explain.

Yes. As mentioned above, the sale of computerized games accounts for a significant portion of total lottery sales and evidences the popularity of these games among the Iowa Lottery's customers. These rules facilitate the conduct of the computerized games offered by the Iowa Lottery while maintaining fairness of play and the integrity of the Lottery's operations.
