For this agreement to be effective, this form must be completed and signed by the nonresident member, then provided to and signed by an authorized representative of the pass-through entity, prior to the pass-through entity's income tax return deadline. **The pass-through entity shall keep this agreement in its records and submit it to the Department only upon request**.
