Web Search Portal/Data Center Annual Report Instructions

Instructions for Web Search Portal/Data Center Annual Report

Each web search portal and data center business wanting to claim an Iowa sales and use tax exemption or refund under Iowa Code section 423.3(92), (93), or (95) is required to file a detailed report of the backup power generation fuel and electricity they purchased during each calendar year. This report is not a method of collecting tax. No tax is due with the report. The report is designed only to gather information, as required by the Iowa Code. The Department will treat these reports as confidential to the same extent as other return information; anonymized aggregate information from the reports may be subject to disclosure, but the Department will not disclose individual report information to the public.

Period: January 1, 2025 through December 31, 2025

Report Due Date: February 2, 2026

Failure to timely file will make the business ineligible to claim an Iowa sales and use tax exemption or refund under Iowa Code section 423.3(92), (93), or (95). Such a business will regain eligibility for exemption or refund when it files the report, provided it otherwise qualifies for the exemption or refund.
