If annual wages are at least \$102,000, multiply the excess over \$101,500.00 by 5.70% (.057) and add it to the last amount in the applicable column.

For employees who do not file a 2024 IA W-4: use \$40.00 as the total allowances amount.

Example: if an employee's annual wages are \$120,000.00 with \$120 total allowances on the IA W-4, the calculation is as follows:

$$(\$120,000.00 - \$101,500.00) \times 5.70\% + \$3,765.11 = \$4,819.61$$
